Order:

Ms. Manvi Bhatt on behalf of the Complainant is present and has stated that the Complainant has already submitted his response to Superintendent Jail, Dehradun which is being taken on the record.

She has also stated that the Complainant has submitted an application and has requested the Commission to intervene for providing proper medical care which has been taken on the record.

The Superintendent Jail, Dehradun shall ensure that the reasonable available medical facility and care shall be provided to the Complainant.

She has requested to be shown to specialist doctors for her mentioned ailments.

The Complainant who is an inmate in the jail and has several ailments and has requested the Commission for her treatment. The Complainant has also mentioned that she has been forced to buy medicines from outside the jail.

The Superintendent Jail, Dehradun shall also ensure all medical facility be provided to the Complainant and report to the Commission explaining the reason why the inmate was forced to buy the medicines from outside.

Copy of the application filed by the Complainant and order be sent to the Superintendent Jail, Dehradun as well as I.G. Jail so that appropriate action is taken and medical facility be available to inmates of the jail.

13 अगस्त, 2015 को एस0पी0 नारकोटिक्स ब्यूरो देहरादून को आदेशित किया गया था कि वह आयोग को अपनी रिपोर्ट प्रस्तुत करें। इसके बाद फिर 15 सितम्बर, 2015 को पुनः आदेशित किया गया था लेकिन एस0पी0 नारकोटिक्स ब्यूरो द्वारा आजतक कोई आख्या प्रस्तुत नहीं की गयी। 15 सितम्बर, 2015 को यह आदेशित किया गया था कि आयोग के पास धारा 18 मानव अधिकार संरक्षण अधिनियम 1993 के अन्तर्गत सभी शक्तियां प्रदत्त हैं, फिर भी एस0पी0 नारकोटिक्स ब्यूरो देहरादून ने नाही कोई आख्या प्रस्तुत की और ना ही अपने बयान रिकार्ड कराये। मा0 आयोग के निबन्धक को आदेशित किया जाता है कि वह एस0पी0 नारकोटिक्स ब्यूरो देहरादून के नाम समन जारी कर आयोग के समक्ष दिशा निर्देश जारी करें, जिससे धारा 18 मानव अधिकार संरक्षण अधिनियम 1993 के अन्तर्गत बयान रिकार्ड किया जा सके।

अगर एस0पी0 नारकोटिक्स ब्यूरो देहरादून आयोग के समक्ष अपने बयान देने नहीं आते हैं तो बाध्य होकर आयोग को उनके खिलाफ वारण्ट जारी करना होगा।

अगली सुनवाई दिनांक 14 दिसम्बर, 2015 को नियत की जाती है।


